\_\_\_\_\_ This course is intended for healthcare providers with current licensure in good standing. An RN license is required for those planning to write the SANE-A or SANE-P certification examination (we may contact you to verify your license). In order to take the SANE/SAFE-A or SANE/SAFE-P courses, you must be a licensed/currently practicing physician, nurse practitioner, or registered nurse.

\_\_\_\_\_ These courses offer ANCC Nursing CE. We do not offer CME or any other type of CEU at this time. We have worked with other organizations, including physician groups, and have qualified to offer accredited training when applied through their official organizations.
