• FP Standard Medical Report (CL489)	For patients that continue to attend work/school and/or daily life is not significantly impacted.
• FP Extended Medical Report (CL489A)	For patients that are off or on modified work/school plans, or are unable to perform daily activities due to MVA-related injuries.
• FP Reassessment Medical Report (CL489B)	For patients whose MVA-related injuries are not recovering as expected and an updated care plan or change in diagnosis is required.
• Physician Specialized Services Report (CL489S)	Only for physicians completing a consultation from another physician or nurse practitioner.
